- Depending on response, repeat exhibits of any given artist's works will be admissible but all effort will be taken to provide for variety.

WHAT IS THE SELECTION PROCESS?

- Members can submit 2 pieces of artwork for selection to TCOfficeGalleries@gmail.com
- The exhibits will be curated by the coordinators and curators to present as a cohesive exhibit, finalized by the venue staff. They will strive to provide an appealing

representation of the strong talent within the BFAA and to best highlight each piece of art in the office space

• The venue's staff will have final approval of the artwork to be displayed.

HOW LONG WILL THE EXHIBIT LAST?

Art will hang for three months. If necessary, the artist may ask the venue coordinator to withdraw their art work after the first month of the exhibit. The artist is responsible to provide artwork in its place.

WHAT ARE EVERYONE'S RESPONSIBILITIES?

- The artist will be responsible for processing any sales of their art work.
- 20% commission is to be forwarded to the BFAA treasurer on all sales.
- The venue coordinator will arrange drop off and pick up times with the venue staff and the artists.
- These are working offices so artists are asked to contact the venue coordinator directly for any questions about the exhibit.
- All art must be original.
- The Burlington Fine Arts Association and The Cooperators are not responsible for the loss of or damage to the submitted artworks.
- All submitted artworks must be wired for hanging according to AGB and BFAA standards.
- All art work must adhere to copyright laws. The artist agrees to secure permissions to reproduce, alter, and display artworks that are not original to the artist.
